President's Report - John Hoheusle

Fellow Members,

The alarming rise in assaults on transit operators is unacceptable—and it has to stop. Each of us who steps onto a coach, shuttle, or light rail vehicle deserves the right to finish our shift in the same condition we started it: safe and unharmed. Yet, too often, we are being asked to shoulder the risk of physical attacks, verbal abuse, and intimidation, while simply doing our jobs.

Transit operators are not punching bags. We are essential workers who provide a vital public service, and we demand the respect and protection that comes with that role.

A Recent Incidents Underscore the Danger

Just in the past few weeks, members of our union have reported being spit on, punched, threatened, and verbally harassed. These incidents are not isolated—they are becoming more frequent, more violent, and more dangerous. Enough is enough!

What We're Demanding

ATU Local758 is calling on management and local authorities to take immediate and meaningful steps, including:

- **Permanent operator barriers** and secure driver compartments
- Increased presence of transit police and security personnel
- Strict enforcement and prosecution of assaults under state and federal laws
- De-escalation and self-defense training—provided regularly and on paid time

A streamlined reporting system for assaults, with full union representation during any investigation

We're also pushing for legislation at the state and federal level that treats assaults on transit workers with the seriousness they deserve.

₩ We Need Every Voice

This fight will not be won in silence. If you've experienced an assault or witnessed one, report it immediately. Then report it to the union. Our power lies in documentation, in numbers, and in solidarity.

If you're frustrated, angry, or scared—you're not alone. But change doesn't happen unless we stand together and speak up. We will continue to raise our voices until meaningful protections are in place for every operator, every shift, every day.

Stay safe. Stay united. We've got your back.

Walt was not only a strong and principled union leader—he was a steadfast friend to the labor movement and a tireless advocate for public transit. His legacy is one of unwavering dedication to fairness, dignity, and opportunity for every transit worker.

As president of the union, Walt played a pivotal role in preserving Sound Transit work and retaining union jobs at Pierce Transit during times of uncertainty and change. His efforts safeguarded livelihoods and strengthened the foundation of transit service in the region

For Walt, the fight for workers' rights wasn't just a job—it was personal. Both he and his beloved wife Linda were transit operators, sharing a deep love for the community they served. In a moment that beautifully captured their shared values, they rode the bus together to their wedding in downtown Tacoma—a testament to their belief in transit, togetherness, and the importance of everyday people.

Walt led with integrity, conviction, and a deep sense of humanity. He believed that strong unions build strong communities, and he worked every day to make that belief a reality.

He will be remembered not only for what he accomplished, but for how he did it—with humor, humility, and heart. Walter Waisath leaves behind a legacy that will continue to guide and inspire, and he will be deeply missed by all who had the privilege of working alongside him.
